E. Purkyně University Statute, and the Faculty of Art and Design Statute. In the academic year 2026/2027, the Faculty of Art and Design (hereinafter "the FUD") opens doctoral study in the programme

NUMBER OF ADMITTED APPLICANTS

The number of applicants to be admitted to doctoral study at FUD is **6** students. In justified cases, the number of admitted students may be increased beyond this determined number by the Dean's decision.

The fee is to cover the administrative service during the admission procedure and is non-refundable.

FILING APPLICATION (AND RELATED REQUIREMENTS)

1. The application for study must be submitted exclusively in electronic form via the university information system STAG at:

https://portal.ujep.cz/portal/studium/uchazec/eprihlaska.html?pc_lang=en

The applicant must indicate the faculty, the form and type of study, and select the study programme to which they are applying.

After completing the electronic application, the applicant is required to pay the admission examination fee in accordance with the instructions provided in the application. Only after the payment is recorded in the system is the application considered officially submitted.

2. The fee of CZK 660 must be paid exclusively by bank transfer to the account of Jan Evangelista Purkyně University in Ústí nad Labem, Československá obchodní banka, Ústí nad Labem, account number 260112295/0300, variable symbol 460509. The specific symbol is generated automatically by the information system.

3. A mandatory part of the electronic application is uploading an authorised conversion of the higher education diploma proving the proper completion of a Master's or Doctoral degree. This must be uploaded no later than the final deadline for submitting the application. The authorised conversion of the diploma can be obtained at Czech POINT contact points. Applicants who will complete their Bachelor's or long-cycle Master's degree in the academic year 2025/2026 are required to upload the authorised conversion of their diploma as soon as they receive it, but **no later than the date of enrolment**.

4. The electronic application must also include:

I. A CV that includes, among other things, the applicant's previous artistic, exhibition, and publishing activities demonstrating the quality of creative outcomes applicable for evaluation in the Register of Artistic Outputs (RUV) or publications in the Register of Information on Results (RIV). II. <u>Framework Project of the Dissertation</u> (2–3 standard pages).

Both attachments must be uploaded in PDF format no later than the final application deadline.

5. A medical certificate is not required.

6. The electronic application can be submitted **from 1 October 2025.**

7. The Faculty does not send confirmation of receipt of the application.

8. Failure to submit the required documents by the given deadlines will be considered as failure to meet one of the necessary conditions for admission.

FORM AND GENERAL CONTENT OF THE ENTRANCE EXAMINATION

- 1. Graduates in the Master's Degree programme of study will be admitted to study after they pass the entrance examination.
- 2. Together with their application form, each applicant will send a CV presenting among others their artistic and publication activities, and a general project of their dissertation (between 2 and 3 standard pages).
- 3. The entrance examination consists of three disciplines: I. expert discourse – presentation of the applicant's activities, and their artistic and
 - publication activities so far II. defence of the general project of dissertation III. an interview in a world language (English or Czech)

classified as 1 – excellent, 2 – very good, 3 – good, 4 – failed.

- 4. Average of this classification decides on the applicant's order. If the average classifications are the same, the order is decided by priorities (1. expert discourse presentation of the applicant's activities, and their artistic and publication activities so far, 2. defence of the general project of dissertation, 3. an interview in a world language). If the applicant is classified as "failed" in any of the disciplines, their overall classification in the entrance examination is "failed" too.
- 5. Entrance examination evaluation criteria: The applicant is evaluated by means of comparison and is classified by the Admission Board.
- 6. Each applicant has the right to leave the entrance examination at any time. They must notify the chairperson of the Admission Board of their decision. This must be done by means of a written statement (or by writing this on the reverse page of the application).

PROVING THE REQUIRED EDUCATION IF ATTAINED ABROAD

- 1. The applicant who has applied for a doctoral study program and has a foreign university education is obliged to prove in the admission procedure the achievement of the required level of university education by a document according to § 48 par. 5 let. a) to c) of the Higher Education Act, as described <u>here.</u>
- 2. The deadline to submit the documents is the same as the deadline to submit the officially certified copy of the university diploma in case of the applicants who are graduates in Master's Degree in the Czech Republic.

ENTRANCE EXAMINATION

- 1. The entrance examination will take place in the announced terms (see "Terms of Entrance Examination").
- 2. The Faculty does not arrange an alternative date of the entrance examination.

3. Applicants will be notified of the entrance examination via e-mail mentioned in application form 10 working days before the exam takes place, at the latest.

DECISION ON ADMISSION TO STUDY

- 1. The Dean of the Faculty will admit applicants based on recommendation of the Admission Board.
- 2. The applicant will be sent a written decision in their own hands within 30 days of verification of conditions for admission to study, however no later than by the day of enrollment in study. A participant whose place of residence will be unknown will be delivered the decision by means of publishing it on the on-line official board.
- 3. The appellate administrative body is the Rector.

ANNOTATION (GRADUATE'S PROFILE)

The main aim of the individually conducted **doctoral study programme of Visual Communication** directed according to each doctoral student's orientation and profile is development of their creative potential in line with deepening of analytical skills and specialized knowledge in the field with an emphasis on contemporary design, graphic design, curatorial studies and visual arts. This conception logically takes up and essentially extends the complex education obtained during the Master's programme of study, and at the same time it emphasizes interdisciplinary and interbranch overlaps, especially in connection with development of new strategies and forms of both artistic and designer work, as well as current and dynamically developing technologies. This happens in compliance with the current allsociety needs and also with respect to compatibility and competitive advantage of our doctoral students versus graduates from foreign art colleges, and with an emphasis on requirements for their future involvement in diverse systems of creative artistic research and art education.

A graduate from the **Visual Communication doctoral programme** is profiled as an independent artist / designer / curator / academic in the fields of visual art, photography and current forms of digital media, graphic design, design and curatorship. In their professional specialization an ability of a theoretical reflection blends together with creative qualifications and activities. As a creative and erudite expert, researcher, and developer, they will find their place in crucial positions of government, public and private spheres (publishers, photographic and picture agencies, graphic studios, specialized graphic workshops, wide range of media, design development centres, digital media, design studios, museums, galleries, and other professional institutions), and also as teachers at art colleges. The graduate is capable of adequate professional / creative reactions to the accelerating external environment, with an extraordinary empathy for the needs and challenges of the 21st century, especially in the fields of technological development, social responsibility and sustainability. They are open to new impulses, knowing that the need for further education does not end with obtaining the doctoral degree, but is merely transformed into a qualitatively higher and narrower specialization.

The study takes place in full-time and combine forms. The standard duration of study is 4 academic years; maximum length of study 7 years.
